I was instrumental in laying the foundation and consequently coordinating and correlating the preliminaries that culminated in the establishment of the Chair and thereby bringing to Logan College not only professional honor and prestige but instructional equipment and salaries.
- 19. I was instrumental in obtaining the Gonstead Scholarship for Logan College. The scholarship has been offered and a recipient selected on six occasions since 1982 and involves one full year tuition, all costs for books and a living expense.
- 20. From June 1977 to July 1978, I served as Chief of Staff of Logan's Chesterfield Clinic.
- 21. From March 1980 to March 1984, I served as Clinic Director of Hosea House (Logan's south St. Louis Clinic) on Wednesday afternoons.
- 22. From March, 1984 to September 1986 I served as one of the Student Clinic Directors on

Wednesday afternoons.

- 23. From September 1986 to September 1990, I served as the Clinic Director at the Logan Chesterfield Clinic on Wednesday afternoons.

- 28. From 1980 to 1987 I maintained Diplomate status in the Gonstead Technique undergoing annual practical and written examinations. I was one of the first 16 chiropractors to be granted this status in 1980. I have reapplied and been reexamined annually since then.
- 29. In July, 1987 I underwent intensive practical, written, and oral examinations and was granted the highest award in the Gonstead Technique, that of Ambassador Status -only the fifth, at that time, to have received it. I am presently maintaining this status.
- 30. I have attended Advanced Gonstead Technique Workshop Seminars twice a year since 1976.
- 31. In May 1983, 1 received a Master's Degree in Clinical Nutrition from the University of Bridgeport.
- 32. I have attended seminars and been granted certification status in motion palpation by the Motion Palpation Institute.
- 33. From 1979 to 1983, I was the Student I.C.A. Faculty Advisor.
